The APSEB Assistant Engineers' Association would like to bring your kind notice on the following crucial issues and request to resolve the issues:

1) Sanction of Additional Posts:

Dear sir due to enormous expansion of the network i.e. new Generating Stations, Substations and Distribution system, the work burden on the employees increased a lot, also sir, there is huge stagnation in Promotions aspects in AP Power Sector which will disturb the morale of the employees and reduces work efficiency (Especially in the Assistant Engineer Cadre it was more than 15 years since joining, waiting for a single promotion).

Hence sir we request you to sanction additional posts immediately and also to fix up Work Load Norms.

2) Seniority of Direct Recruited AEs' vs Conversion AEs':

Vide.Ref2,Lr.No.Addl.Secy/DS(L,IR&R)/AS(L,IR&R)/PO(IR)/
610/2015, Dt:28.03.2017 Management has promised to constitute a committee on this issue. Hence we request the Management to constitute a committee to resolve this issue on top priority.

3) **Expansion of APGENCO in Non-Conventional Energy Sources:**

No doubt that APGENCO is one the best performing power utilities in the country, but the Installed capacity (Solar 1*5MW + Wind 10*0.2MW) of APGENCO in the Non Conventional Energy sources was very low. Hence we request the Management of APGENCO to expand the Installed Capacity in Non-Conventional Energy Sources (Solar & Wind).

4) **Redesignation of AE to AEE:**

Vide Refl. T.O.O. Ms.No 296 (Addl.Secy-Per) Dt:08-11-2016 a committee was constituted to Re-designate the present Assistant Engineer Cadre as Assistant Executive Engineer but sir it was almost 6 months this issue was pending, hence we request the Management to resolve this issue on priority.
